## Requirements for Participating Artists/Studios:

- 1 Studios must be open 10:00 am – 5:00 pm September 18th. Artists must be present and available.
- 2 Studio space must be suitable to show work.
- 3 Studios must be large enough to accommodate tour visitors.
- 4 Studios must be located within Park County, Montana.
- 5 During the tour, studios must sell only work by participating tour artists who have been accepted and paid the participation fee. No sales commissions/fees will be taken.
- 6 Studios must include an actual art production area, art galleries or educational venues without individual working space will not be eligible.
- 7 Studios are encouraged to provide refreshments.
- 8 Park County Friends of the Arts will sell tickets for the studio tour. Proceeds will go towards non-profit public arts programs in Park County.
- 9 If artists share their studios, each artist displaying artwork must pay the full participation fee.
- 10 **Artists must provide at least one digital image** (JPG file no larger than 1mb) of their artwork to be used for promotional purposes. By providing an image, the artist forfeits usage rights to Park County Friends of the Arts and The Danforth Gallery.
- 11 Artists must provide driving directions (from Livingston) and street address of studio.

## Application Fees and Deadline:

- **Studio tour participation fees and applications (for artists) must be received by August 7th, 2010—no exceptions.**
- Fees for participating artists are \$85 or \$75 for Park County Friends of the Arts members. If artists share their studios, each artist displaying artwork must pay the full participation fee.
- Studio tour participation fees and applications should be mailed to The Danforth Gallery, PO Box 1341, Livingston, MT 59047. Make checks payable to: Park County Friends of the Arts. If you prefer to pay by credit card, hand deliver your application to The Danforth Gallery at 106 N. Main in Livingston or call 406-222-6510.
- If for whatever reason, an artist cancels after paying the participation fee, no refund will be granted.
